Government bond auction results

Yesterday, for the first time this year, the MoF cancelled its scheduled auction and did not sell any 2-year bonds. Both bids for a total of UAH115m at 19.80% and 20.90% were rejected as they were above the yield curve and demand was too low to push the yield curve higher.

Compared with previous auctions, demand fell significantly despite the high level of liquidity in the banking system and the cancellation of the 3-month CD offering by the NBU. The NBU also did not publish the results of its auction either because of low demand or that the auction will be extended to three days.

Yesterday's results from both the MoF and NBU auctions could indicate that demand for bonds has declined, possibly due to the recent weakening of the local currency. These results should give a broader market view on government bonds at the moment.





Chart 1. History of yields at government bond auctions: breakdown by tenor of bonds sold (last 3-year period)








Chart 3. Schedule of redemptions of the local-currency government bonds*
