Low demand

Government bond auction results

On Tuesday, the MoF continued to offer the same indexed bonds that were offered last week as it sold UAH2.7bn of them, up 270% from last week, but once more to only one bidder, at the same 6.5% rate.

Meanwhile, as regular bonds attracted minimal demand on Tuesday, the auction was cancelled. Out of the four offered bonds, only the 2-year bond received one bid for UAH10m at 16.0%. It was rejected due to the small amount.

This auction was ignored by the market, following the large amount of bonds sold last week. The scheduled tax payments and public holiday also affected cash flows, decreasing demand for the new bonds.


Although demand could rise slightly next week as month-end tax payments are completed and investors meet portfolio needss by the reporting date, but this should be insignificant. Demand should rise in September, especially if the FX market stabilizes and the NBU restarts FX auctions.

Chart 2. History of proceeds at government bond auctions: breakdown by tenor of bonds sold (last 3-year period)





Chart 3. Schedule of redemptions of the local-currency government bonds*
