Auction cancelled by the MoF

WEDNESDAY, 5 OCTOBER 2016

Government bond auction results

With only UAH1.25bn of debt repayments, including only UAH12.5m of principal repayments, scheduled in the first week of October, and with UAH13.47bn in the treasury account, the MoF had no need to raise funds this week.

Currently, demand for new bonds us uncertain as banking sector liquidity is low and was quite volatile at the end of last month, even though it rose last week to above UAH80bn due to the significant VAT refund. Because of this, demand for new bonds could rise slightly next week when the MoF will offer 2-year bonds instead of the 5year bonds offered yesterday. However, this demand should be insignificant as liquidity should be reallocated from CDs to bonds as occurred earlier this year. Only additional liquidity or debt repayments could be the source for new demand.

Next week, the MoF has slightly higher debt principal repayments of UAH0.28bn and UAH1.19bn in debt interest repayments. With market demand of only about UAH0.30bn of funds, these could be invested in new government bonds.

Chart 2. History of proceeds at government bond auctions: breakdown by tenor of bonds sold (last 3-year period)





Chart 3. Schedule of redemptions of the local-currency government bonds*
