Another auction with no proceeds

Government bond auction results

As last week's auction provided the MoF with paltry budget proceeds, yesterday's auction could be deemed the fourth consecutive auction with little to no proceeds from the primary bond market.

But while recent weeks saw some bids, yesterday the MoF received no bids, possibly due to the recent significant decline in banking sector liquidity, unattractive interest rates at the primary market and insufficient debt repayments to the market.

This could have caused the revision of auction schedule for December with an extended offering of FX-denominated bonds, incentivizing some potential bidders to postpone their investments to mid-December, pushing them toward two-week CDs or investments at the secondary market.

We could see little to no demand next week; the most active auctions will be on 13 and 20 December, with demand declining again at the end of the year.

Chart 2. History of proceeds at government bond auctions: breakdown by tenor of bonds sold (last 3-year period)





Chart 3. Schedule of redemptions of the local-currency government bonds*
