Liquidity steady

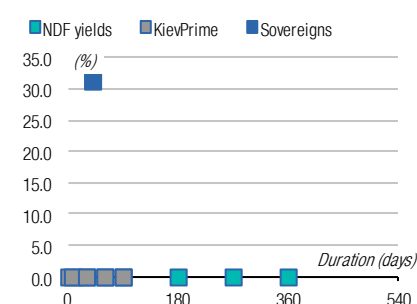
Banking sector liquidity remained steady, down a mere UAH0.16bn to UAH74.20bn yesterday, as banks' correspondent accounts with the NBU slid UAH0.04bn to UAH41.36bn while total CDs outstanding declined UAH0.12bn to UAH32.84bn.

Investment implications: The state budget collected UAH5.40bn on Tuesday. With lower expenditures and UAH0.33bn of inflows from the NBU via an FX auction, liquidity declined slightly. As yesterday was the last day of month-end tax payments, and the NBU purchased US\$34.8m of FX by paying UAH0.89bn into the banking system, liquidity could slightly decline today but not significantly, depending on MoF expenditures.

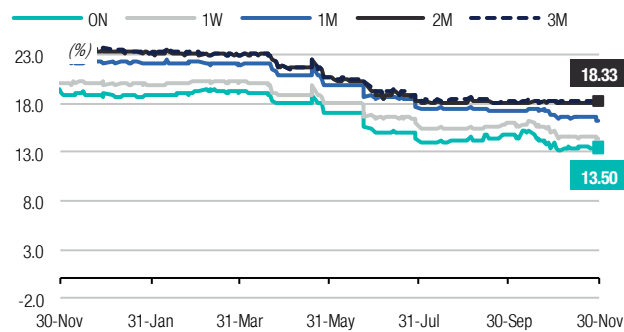

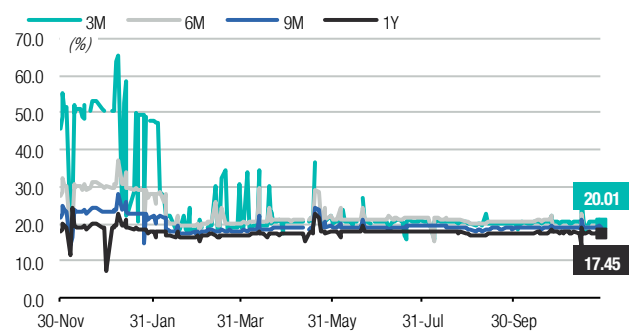

Chart 1. Kiev Prime rates (%), last 12-month period



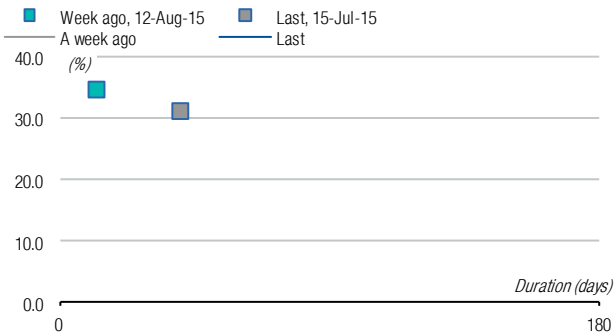

Chart 2. UAH NDF implied yields (%), last 12-month period



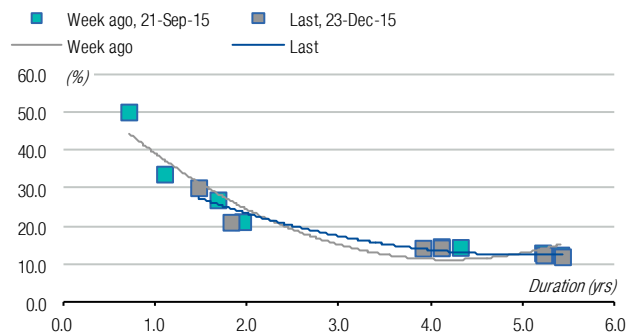

Chart 3. UAH sovereign yield curve (%) as of 30 Nov 2016



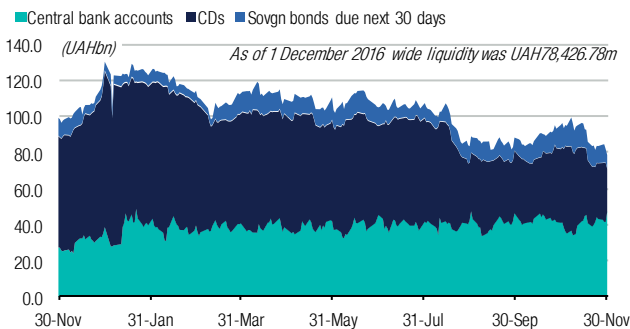

Chart 4. USD sovereign yield curve (%) as of 30 Nov 2016



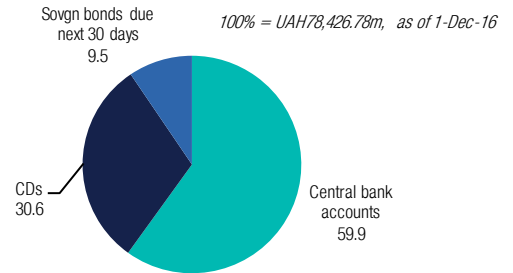

Chart 5. Banking sector liquidity (UAHbn), last 12-month period



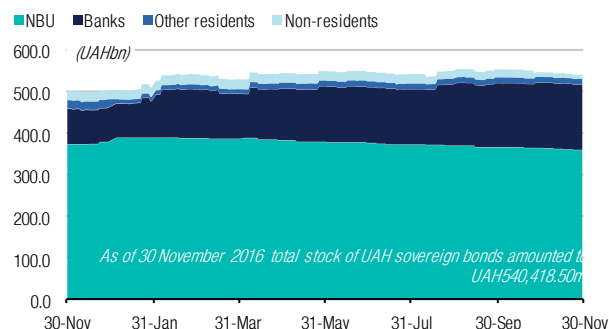

Chart 6. Breakdown of liquidity pool (%) as of 30 Nov 2016



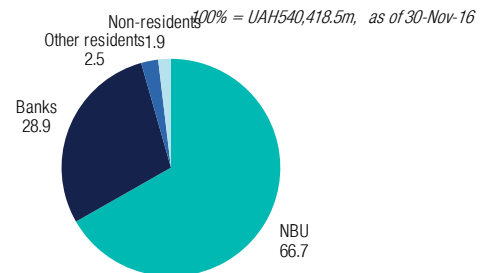

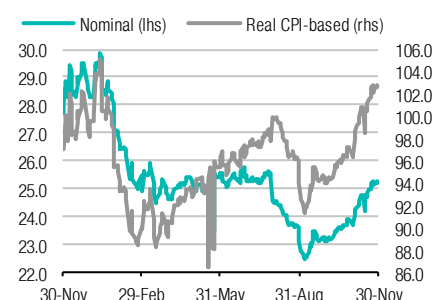

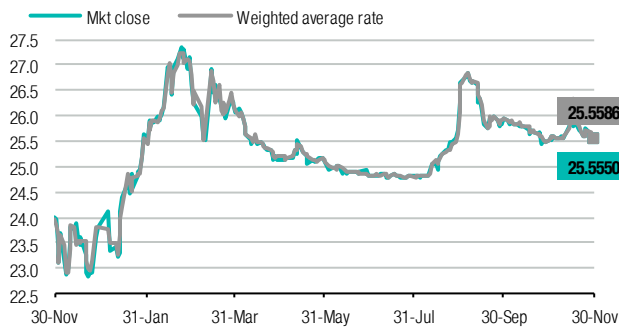

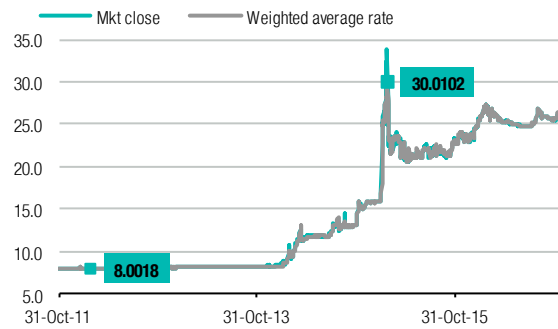

Chart 9. Spot market rates USD/UAH: last 12-month and 5-year periods (UAH per USD, left and right respectively)

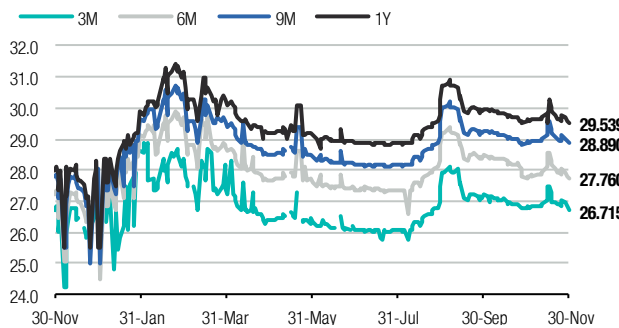

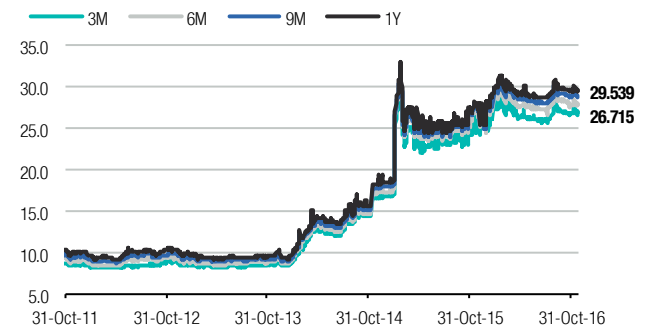

Chart 10. NDF market rates USD/UAH: last 12-month and 5-year periods (UAH per USD, left and right respectively)

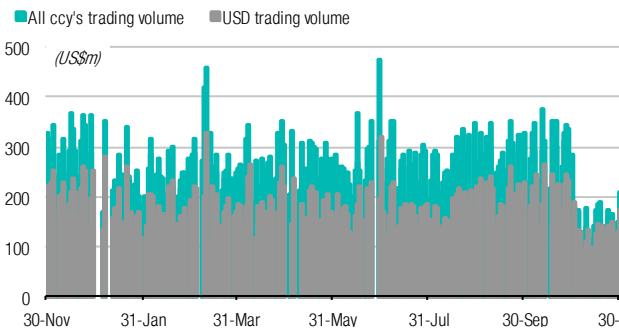

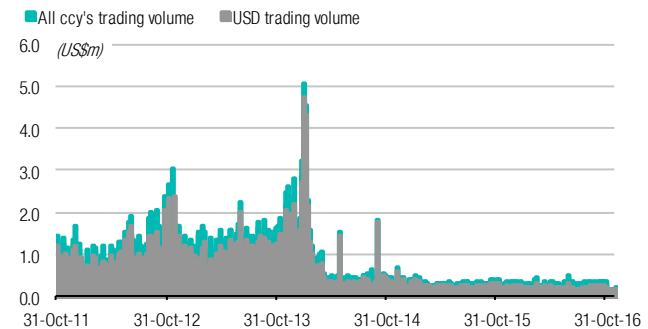

Chart 11. Trading volume: last 12-month and 5-year periods (US\$m, left and right respectively)

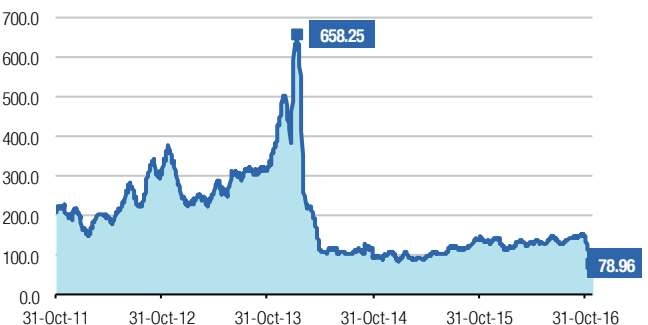
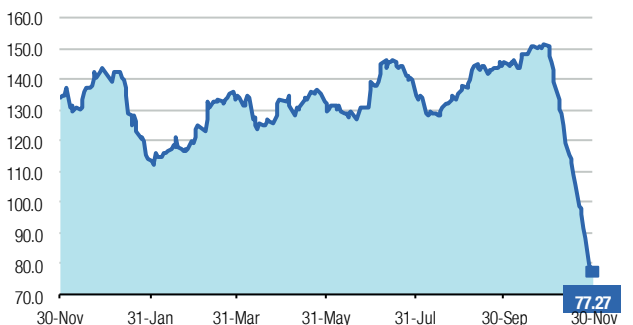

Chart 12. 30D MA* ratio of FX market turnover to merchandise trade: last 12m and 5yr periods (% , left and right respectively)

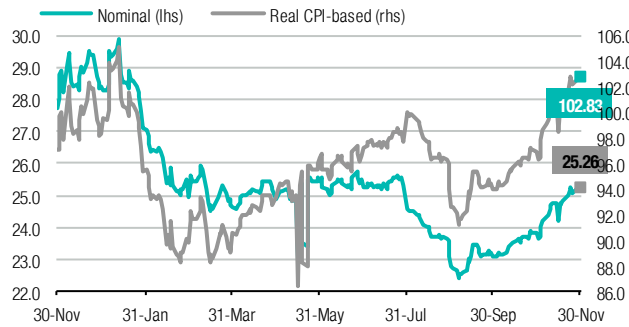

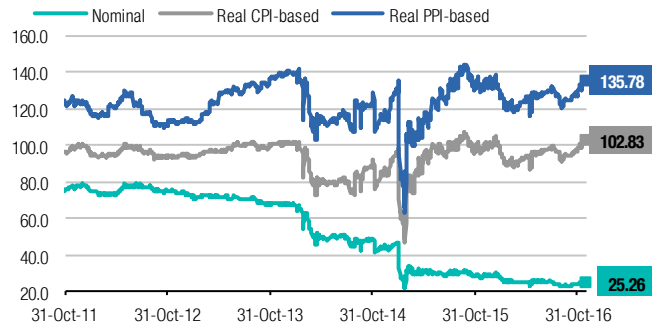

Chart 13. Nominal and CPI-based real TWIs of UAH, history of last 12-month period



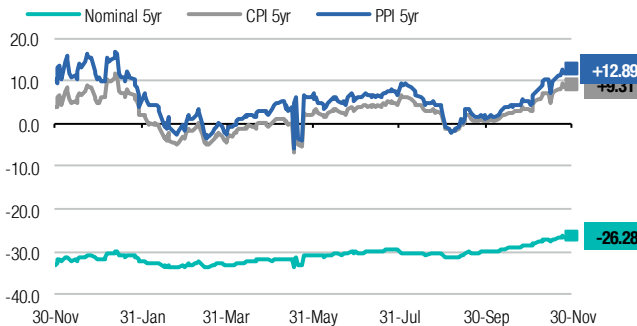

Chart 14. Nominal, CPI- and PPI-based TWIs of UAH, history of last 5-year period

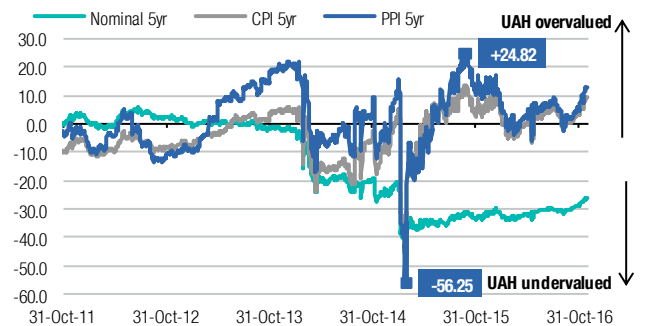

Chart 15. Deviation of UAH trade-weighted indices from their 5-year moving averages: last 12-month and 5-year periods (% , left and right respectively)

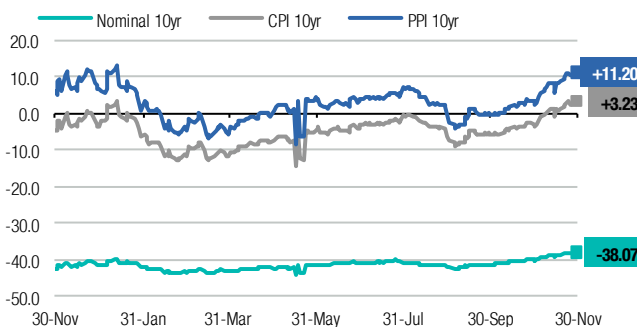

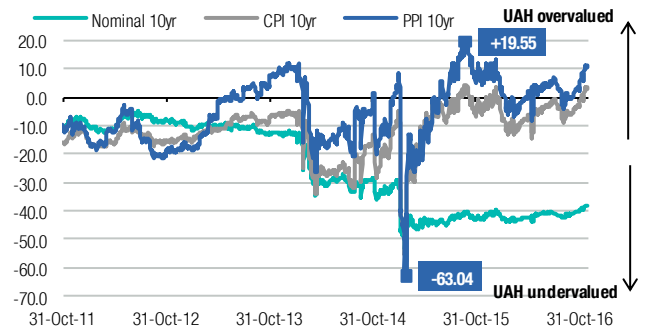
