

Bond Market Insight

Government bond auction results: No market demand

WEDNESDAY, 6 AUGUST, 2014

The MoF received only one small bid of UAH10.0m (par value) for the 2-year bond at yesterday's primary auction. Although the interest rate was the routine 16.75% for this maturity, the MoF rejected the bid because of its insignificant size.

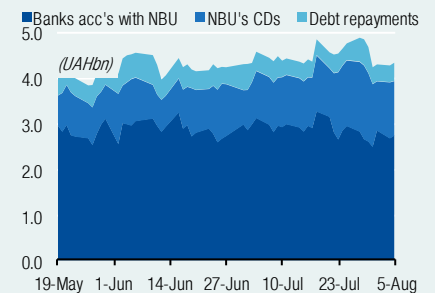
As no domestic QE support appeared to be provided at this offering, there were no bids for the other offerings. An unscheduled auction could be held offering long-term bonds which normally raise funds only through domestic QE supported bids.

However, as today's interest repayments were a paltry UAH0.48bn denominated mostly in local currency, the MoF had no need to refinance. If an unscheduled auction with domestic QE support is held, this could indicate that the state budget needs additional funds to finance current needs.

Historical breakdown of local financial market liquidity (UAHbn)

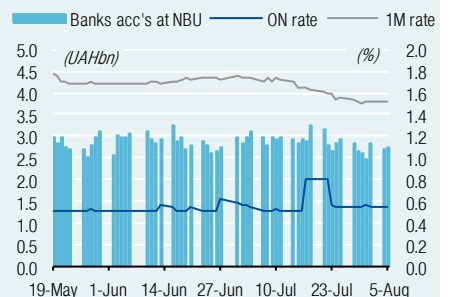
Last 3-month period

Banks' acc' with the NBU and KyivPrime interest rates.

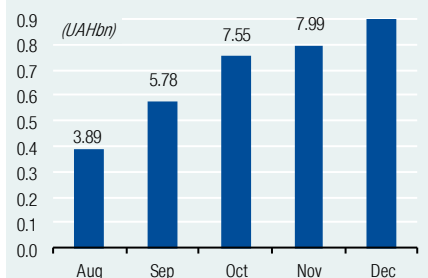
Last 3-month period

Until the end of 2014



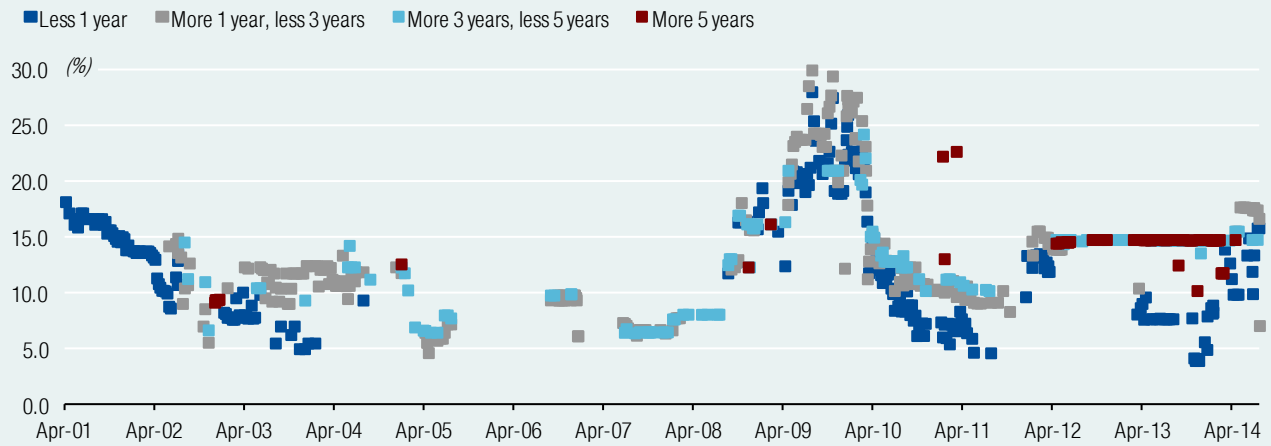

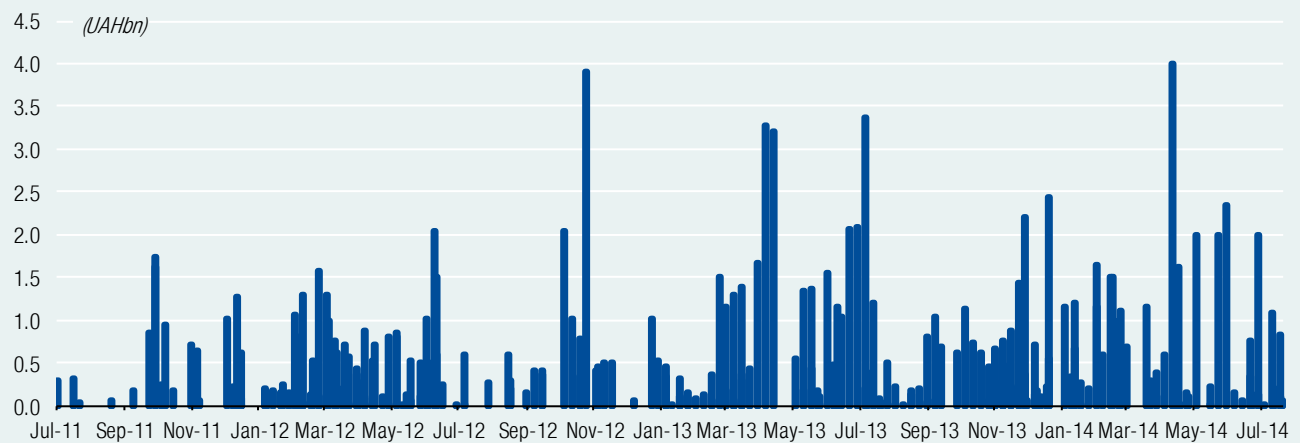
